

**NOTICE TO ALL MEMBERS  
NATIONAL ALLIED WORKERS UNION LOCAL 831  
NOMINATION OF OFFICERS**

An election of officers for the term July 1, 2020 - June 30, 2023 shall be held this year. Due to the COVID-19 pandemic, a “stay-at-home” order has been issued in Illinois (as well as almost every other state) by Governor J.B. Pritzker (Illinois Executive Order 2020-10 (“Order”)) that permits individuals to leave their homes only for essential functions through the end of April. While activities essential to a union’s operation are permitted, the Order does not specifically address holding union elections, and gathering in a group of more than 10 runs counter to the Order and federally issued social distancing guidance. The Office of Labor-Management Standards (OLMS) has advised that labor unions affected by COVID-19 must make a good faith effort to conduct officer elections within the required time frame. In light of the Order as well as the OLMS guidance, the Local’s Executive Board has resolved to conduct the election process, including the nomination process, by mail.
